# Part Time Fire Official Effective January 1, 2022

Must obtain a current NJ Fire Official Certificate from the Department of Community Affairs

Position is not to exceed 20 hours a week @ \$30.00 per hour

Hours to be completed Sunday -Saturday, need to advise Fire Prevention office of available hours for the month for scheduled inspections.

Hours must be submitted to the online payroll company as per payroll schedule Any call out from dispatch, Chief, Officer on duty, minimum 2 hours paid, must notify the Fire Prevention office of call out and hours on scene.

Paid monthly on the 30th of each month

Allotment for Fire Official related courses for official license

No hourly pay allotment for courses taken

Paid Time Off will be accrued as per NJ PTO off law (1 hour for every 30 hours worked) Accrued PTO- as per PTO no more than 40 hours can be carried over per benefit year. Accrued PTO will be paid at the end of the first quarter Up-to 40 hours may accrued and used in a benefit year PTO must be submitted to the Administrative Clerk, 7 days prior to foreseeable leave Reasonable documentation is required for 3 or more consecutive work days of PTO Upon termination PTO is not reimbursed.

No health benefits shall be provided Shall not be enrolled in NJ PERS

Vehicle-The Fire Official will have use of the district owned Fire Official vehicle, for inspections, calls, etc. The fire official vehicle will be parked at the township municipal building parking lot. A key will be left in the fire prevention office, for any necessary alternate use needed.
