### NOTICE OF INTENT TO AWARD CONTRACT UNDER A NATIONAL COOPERATIVE PURCHASING AGREEMENT

PLEASE TAKE NOTICE that the Commissioners of Fire District No. 1 in the Township of Hazlet (the "Fire District") intends to participate in the Houston-Galveston Area Council (HGAC) Cooperative Purchasing Program for the acquisition of a Firetruck. Information regarding the contract may be found at the administrative offices of the Board of Fire Commissioners, Hazlet Township Fire District Office, 812 Poole Ave. Suite A, Hazlet, NJ 07730 during regular business hours as well as on the website of the Houston-Galveston Area Council: HGACBuy.org. The Fire District authorized membership in the HGAC Cooperative Purchasing Program in a resolution previously adopted by the Fire District. A contract was signed between the Fire District and HGAC. It is the intent of the Fire District to purchase the Firetruck from Toyne. The Contract price for the fire apparatus was established by HGAC, pursuant to its receipt of bids for such fire apparatus.
