#### (2) INSURANCE

VFIS risk Assessment meeting, all paperwork was submitted and they acknowledged receipt and review of all sent.

Comms. Parleman and Schroeck met with the chiefs to go over policies, minor changes were made and accepted. Will adopt at the regular meeting.

### (8) PERSONNEL POLICY

### (9) NEW MEMBER ORDINANCE

The old ordinance by the township needs to be rescinded, as member applications are not processed through the township. A new resolution for member criteria needs to be made and adopted as soon as possible.

### (10) TIPS TRAINING COURSE

Regarding serving alcohol at rentals, TIPS training needed, on advice of the insurance company, the fire companies that serve alcohol will require to have the members that bartend attend a TIPS training class. Michelle looked into it and there is not a free class, the board will discuss with the Presidents how many members will need the training and it can be budgeted out of training line item. There should be an initial training and then refresher about every 3 years.

#### (11) AIR COMPRESSOR

Quick fill purchase, received 2 quotes, to go with the Air Pak International was who the compressor was purchased from and their quote was the lowest. Board was in favor. Michelle will place the order for the quick fill adaptor.
