Commissioner Parleman read the following statement:

The Board over the past year has been discussing and investigating in length, the needs of the district for fire protection, the safety of the volunteer firefighters and the residents, and the burden on the taxpayers.

The board realizes that older apparatus needs to be replaced, With the rising cost of apparatus and the long delivery times, the board has determined that the district would benefit the most by replacing the 2003 pumper from West Keansburg Fire Company. The purchase to be approved by the legal voters of Hazlet Township for the 2024 budget year. The board is requesting full support from all firefighters and residents. We are then looking into the purchase of apparatus to replace the 1989 Tower from Hazlet Fire Company with a special election in 2024 with a purchase year in 2025. These decisions were made on the basis of financing, available capital funds, burden of the taxpayers, sale of older apparatus, and many other factors.

The board will be passing a resolution to authorize the Special Election for the purchase of fire apparatus, this election in accordance with state statute will be held on Monday July 24th, between 2pm and 9pm.
