## **OLD BUSINESS**

Comm. Parleman read a letter from the auditor praising the good work that the Hazlet Fire District has done this year. Michelle is working directly with the Auditor, receiving an email commending herself and Tom Furlong for their excellent work, Michelle also informed the board that working with the Auditor is reviewing individual line items and questioning items purchased, amount spent, etc. Comm. JC Schroeck asked the attorney if this is normal, Rich stated the State of NJ is becoming more strict with the oversight of audits, that DCA is strictly enforcing, that recommendations are being followed through, and also stated as a district we are far ahead of many others in the state with audit reviews.

American rescue grant - no progress in receiving the needed UEI number, Michelle attended an informative webinar on the grant and most districts are having an issue filing for this grant. It is a match-based grant, and the district would need to know exactly what they wanted to buy up to \$75,000. Unfortunately, with these issues we will not be able to file this year.

Comm. JC Schroeck mentioned that last month it was asked of all the companies to submit any outstanding training reports, drivers' licenses of all personnel that will drive any apparatus so that it can all be logged in.

The Fit Test machine should be back to Michelle so that the Board can send out to get calibrated and have ready for next year.

William McCarron, 46 7<sup>th</sup> Street, Hazlet – Speaking on behalf of the WKFC, would like clarification as to why 2 new members were brought into Closed Session as it is not in the policy. Comm. Parleman mentioned that they were just congratulated.

Matt Schmidt, 55 2<sup>nd</sup> Street, Hazlet, what is the reason for Comm. Sheldrick to be virtual and not the public. Comm. Parleman answered that he needed to be at this meeting for some business that he needed to be involved with. The public can attend the meeting if they wanted to.

Michael Storks, 91 5<sup>th</sup> Street, Hazlet, congratulated Michelle on a good job with the minutes, Michelle replied that she did not do the minutes, but still noted that a good job was done by whoever did them. It was written that Comm. Parleman was berated by Mr. Storks, what was said was the Secretary berated Mr. Storks and that it should be on record. It was not put in the minutes that Mr. Storks was called outside by Comm. Parleman during a public meeting, just want that on record as well.

Has the social media policy been modified? Comm. Parleman tried to reply but Mr. Storks cut him short by mentioning that he didn't want any issues and didn't want to get called outside.

Any updates on recruitment and retention? Its good to see the sign outside trying to get new members. Its still a drop in the bucket. Its good to see a couple new members, cadets and other firemen that are already active. When was the last time the ISO assessment was done? Any idea what the rating is now? Membership carries a large amount of points when it comes to updating the ISO records. The Board raised taxes, gave yourselves raises, moved out of Town Hall, incurred monthly bills, which the bills were not available to us up until a couple minutes ago, just want to make a note of that, before you went into Closed Session or behind your desk like last month, sounds like you are trying to keep taxpayer money, are you speaking of taxpayer money or involvement in decisions, you are pushing yourselves away and business away from the public with every move you guys make, are you guys up there for the residents and district, or for yourselves. That's all I have to say, thank you.

Michelle noted that the list of bills are put out after they are approved, not before.

Mr. Storks mentioned that the administrative clerk said that you were not allowed to do virtual. Rich Braslow noted that the DCA issued a memo for all public entities, that said that there is no longer a state of emergency so that they would not like meetings to be held virtually. That is all I can say. Mr. Storks noted that the email to Jason Martucci left it open, to me unless I am interpreting it incorrectly. He

also noted that Michelle said it was illegal, but Michelle noted that she did not say illegal but not allowed. The Board agreed to have Mr. Braslow contact Mr. Martucci for clarification.
