WHEREAS, the Fire District deems it necessary to purchase a command vehicle for The Bureau of Fire Prevention not to exceed \$45,000 and; the purchase of real property with related expenses not to exceed \$150,000 and;

WHEREAS, in compliance with N.J.S.A. 40A; 14-84 a public hearing shall be held by the Fire District to allow the public the opportunity to be heard concerning the proposed expenditures. NOW THEREFORE, be it RESOLVED by the Commissioners of Fire District in the Township of Hazlet, County of Monmouth, as follows



A public hearing shall be held by Fire District relative to the proposed expenditures for the purchase of a command vehicle for The Bureau of Fire Prevention in the amount not to exceed \$45,000, and the purchase of real property and related expenses not to exceed \$150,000. The public hearing shall be held on Wednesday, September 8, 2021 at 8:00pm at Hazlet Township Municipal Building, 1766 Union Ave., Hazlet, NJ 07730

2. Copies of the resolution are available to the general public of the Fire District from the date following publication of this resolution up to and including the date of the meeting.
3. This resolution shall be published and posted in accordance with the requirements of the New Jersey statute.
4. After the public hearing the Fire District may adopt the resolution authorizing the purchase of a command vehicle for The Bureau of Fire Prevention in the amount not to exceed \$45,000, and the purchase of real property and related expenses not to exceed \$150,000.


