	He pro	hereby elects to adopt the provisions of Chapter 88 and adhere to the rules and regulations promulgated by the State Health Benefits Commission (SHBC) or School Employees' Health Benefits Commission (SEHBC) to implement the provisions of the law. We hereby acknowledge that the rules and regulations of the SHBC/SEHBC established that Chapter 88 does:							
	a.	Apply to all eligible current and future retirees of the employer and their dependents;							
	b.	<ul> <li>Continue as long as the State is paying the cost of its eligible retirees and their dependents in accordance with the provision of P.L. 1972, c. 75 (Chapter 75);</li> </ul>							
	C.	c. Provide for local employer reimbursement of Medicare Part B premiums for eligible retirees and/or their spouses as the payment of health insurance premiums required by the Program on a basis comparable to the reimburse- ment made by the State to its eligible retirees and their spouses in accordance with the provisions of Chapter 75; and							
	<ol> <li>Require the local employer to pay the full cost of such premiums up to the cost of NJ DIRECT10 coverage.</li> </ol>
